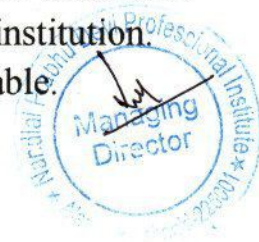

- (iv) Withhold or refuse to return any document in the form of certificates of degree, diploma or any other award or other document deposited with it by a person for the purpose of seeking admission in institution, with a view to induce or compel such person to pay any fees in respect of programme of study which such person does not intend to pursue.
- (v) Demand of money in excess of that specified in the declared admission policy or approved by the competent authority to be charge by institution.
- (vi) Breach of policy for reservation in admission as may be applicable.
